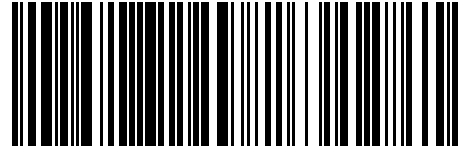

DEAR PRIME MINISTER LAPID,

The Nation of Israel warmly sends greetings to Jerusalem; and hereby proffers the enclosed Resolution to the *de facto* State of Israel through your person. In keeping with the mores of international law and possessing a genuine concern for the general welfare of Humanity, we sincerely hope for the opportunity for partnership that promotes world peace and combats anti-Semitism in the form of unprovoked, unlawful persecution of God's Chosen People in America and around the world.

Nationhood and International Law Jurisdiction

As of Friday, December 16, 2022, legal Notice of Nationhood (**NATIONAL REGISTER DOC ID: ME1-US1-12.16.2022**) has been duly issued for service upon the United States of America republic. Having formally reconstituted as an hereditary Nation with the penning of Har Tsiyon's Constitution in July 2022, we are elated to be reclothed with our Israeltish nationality and the peremptory *human dignity* therewith provided. With this, the Twelve Tribes are honored to rejoin the Human Family of nations, humbled by the goodness and everlasting mercy of our God and Father, *Yahuah Elohiym*, who saw fit to breathe life once again into these heretofore Dry Bones.

- a. Our Body now resurrected; Israel recognizes the Duties incumbent upon us as a Nation in the realm of international polity.
- b. Israel accepts the Rights and Responsibilities that international law attaches pertaining to our human, political, civil, and social rights.
- c. As upstanding Citizens of the international community, we stand prepared to peacefully negotiate or otherwise discuss our Affairs with the Israeli People through the agency of their *de facto* Government in a public forum furnished by the United Nations or other appropriate international symposium.

Genetic Affinity to Israel and Palestine

All Praises to the *Most High GOD*; modern science has conclusively deduced and empirically substantiated that we are the genetic Offspring of the original inhabitants of the countries presently referred to as Israel and Palestine,¹ known in the Old World as the Northern and Southern Kingdoms of ancient Israel.

- a. The international doctrine of the *right of return* stipulates that the original peoples of a given country have the incontestable privilege of returning to their Homeland. Contrary to said doctrine, *de facto* Israeli organic and

statutory "law"—or *Policy*, rather— has been in direct opposition to the Rule of Law in that:

- i. Jewish and other non-Semitic Israeli persons are without a valid claim to Ancient Israel in point of law absent biological descent from the Hebrew Patriarchs Abraham, Isaac, and Jacob.²
- ii. Israeli protocol has formerly been to deport—or more precisely, *exile*—Israelitish persons from our Home, in the vein of *extreme anti-Semitism*.
- iii. Despite being a State Party to the *International Convention on the Elimination of All Forms of Racial Discrimination*, the Israeli People— by and through their Government— have circumvented international law in similar fashion to that previously employed in America. In other words, you assigned them a **sub-human legal status** by mislabeling our Israelitish brethren "Blacks", "Africans", or other *colored* persons, as has been customary of West Powers.³ By superficially excluding them from the Human Family, you artificially avoided your legal Responsibilities.⁴
- iv. As the sole Legal Heir to Israel and Palestine, we are hoping to open an honest dialogue about human rights violations in our Homeland and work toward peaceful solutions, as we are greatly concerned with and troubled by Israeli mistreatment of the human person.

Combatting Anti-Semitism and Promoting Peace

- a. There has been a *massive* Holocaust against Israelites and other Semitic persons in the Middle East in which the Jewish People have played a considerable role.⁵ We were hoping you would join with us in peacefully combatting anti-Semitism by:
 - i. Publicly denouncing hatred and mistreatment of Semitic persons around the world.

- ii. Meeting with Israelitish leaders to get educated on the dire effect and consequences of your actions on the Biblical Hebrews and better understand the plight of the Israelitish Diaspora. Although there are no extant Hebrew Holocaust museums, we invite the Jewish Community to contribute their long-standing victim recovery expertise to educate the world on the largest atrocity in human history: the Transatlantic Slavetrade. This would be a tremendous show of growth and willingness to take accountability for your actions.
 - iii. Issue a written statement reprehending the continued persecution and defamation of God's Chosen People by Jewish-led organizations, including but not limited to the U.S.-based Anti-Defamation League (ADL), and the Southern Poverty Law Center (SPLC).
 - iv. Making a monetary gift to our Nation commensurate with the damages caused by the Jews' having assumed our Identity.
- b. We feel it congruous to expressly acknowledge that the propagandization of anti-Semitism by Israeli and Jewish persons, businesses, and other organizations has resulted in the proliferation of anti-Semitic tropes and victimization of Israelites, which vexation is in violation of the U.S. Constitution and Laws.
- v. Groups such as the U.S.-based Anti-Defamation League (ADL), and the Southern Poverty Law Center (SPLC) were formed in accordance with and operate pursuant state and federal Codes (i.e., United States Code, Official Code of Georgia Annotated, etc.), under the U.S. Government which is a Democracy that has betrayed the American People and compromised that Nation.⁶
 - vi. Yet and still, the United States of America are a Republic,⁷ to which the said Democracy is subordinate. No trespass upon the person or reputation and property of the Biblical Hebrews is permissible under the Laws of the Republic, for which species of Rights the U.S. Constitution and Government formed thereby were specifically established to protect. Consequently, the Jewish Community is involved in Criminal Trespass and is supporting the subversion of the U.S. Constitution. We are asking that the Jewish State condemn the insurrectionary behaviour of the Jews against the American People.
